2015 CAGAYAN VALLEY REGIONAL ATHLETIC ASSOCIATION (CAVRAA) MEET

To: Schools Division/City Superintendents
Heads, Public and Private Elementary and Secondary Schools.
All Others Concerned

1. Pursuant to Section 14.2 of the Implementing Rules and Regulations of Republic Act No. 9155, otherwise known as the Governance of Basic Education Act of 2001, School Sports and Physical Fitness shall continue to be the responsibility of basic education. To perform this function, the 2015 Cagayan Valley Regional Athletic Association (CAVRAA) Meet be scheduled on February 26 to March 1, 2015 which will be hosted by the Province of Nueva Vizcaya with the Schools Division of Nueva Vizcaya at the Nueva Vizcaya Sports Complex, Bayombong, Nueva Vizcaya.
2. Corollary with the nation's vision of growth and equity, the theme of the 2015 CAVRAA Meet is "Quality Sports: Road to Peace and Progress".
3. To efficiently and successfully manage the Meet, the following policies are adopted:
 - 3.1 The Department of Education, Region 02, in coordination with the various Schools Division Offices in the region, will oversee the management of the 2015 CAVRAA Meet. The Schools Division Offices will take charge of the preparation of their respective division athletic delegations.
 - 3.2 The host Schools Division Office/schools will be responsible for the provision, preparation and readiness of facilities, billeting quarters and amenities.
 - 3.3 The Regional Office will be responsible for the procurement of official playing balls.
4. Pursuant to DepED Memorandum No. 49, s. 2014, the **Olympic Medal System** shall be applied for this year's CAVRAA Meet to determine the general championship.
5. To promote a clean and green environment, the use of disposable plastic wares and Styrofoam shall be prohibited during the Meet.

6. Regular and demonstration events participated in by less than fifty percent (50%) of the participating divisions will be considered a demonstration sports in which medals earned will not accrue to the general ranking.
7. Measurable events like Athletics, Swimming, and Archery will be closely monitored. Only athletes who shall meet the Palaro standard record will be qualified to participate in the Palarong Pambansa in Tagum City. Team, Dual and Individual events athletes will be selected to join the CAVRAA delegation to the 2015 PALARO if their performance is at par with Palaro standards.

9. The provisions of DepED Order NO. 53, s.2003 entitled **Updated Guidelines on the Grant of Vacation Service Credits to Teachers** shall apply to technical officials, coaches and other members of the different working committees who shall serve during the Meet.
10. Expenses relative to the training and participation of the delegations shall be charged to local funds. Foods and snacks of the technical officials shall be charged to regional office fund while their transportation expenses shall be charged to local funds.
