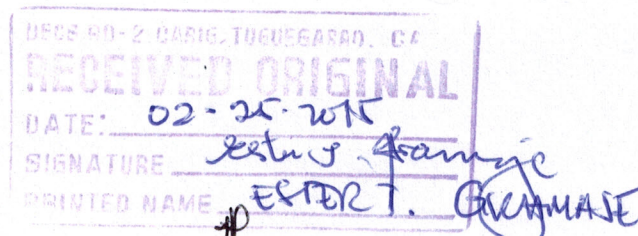
QUARTERLY CONFERENCE WORKSHOP OF SSES, STE, RSHS AND SPED IMPLEMENTERS

To : All Schools Division/City Superintendents

1. The Special Science Elementary Schools (SSES), Science Technology and Engineering program (STEP), formerly ESEP, Regional Science High School (RSHS) and Special Education (SPED) are special programs launched by the DepED to support and strengthen the mandate of the state to prioritize Science and Technology Education for children who are gifted, talented and with special needs. These programs are designed to develop Filipino children who are equipped with scientific and technological knowledge, skills, and attitudes, creativity and have positive values, lifelong learning skills and become globally competitive.
2. The Curriculum and Management Learning Division (CLMD), DepEd R02 will conduct a two-day Conference Workshop for the SPED, SSES, STE, and RSHS at the DepEd Conference Hall on March 17-18, 2015.
