**CREATION/ORGANIZATION OF THE CHILD PROTECTION
 COMMITTEE IN THE DIVISION OFFICES AND SCHOOL LEVEL
 (ELEMENTARY AND SECONDARY)**

To: All Schools Division/City Superintendents

1. Pursuant to DepED Order No. 40, series of 2012 otherwise known as the **“DepED Child Protection Policy (Policy and Guidelines on Protecting Children in School from Abuse, Violence, Exploitation, Discrimination, Bullying and other Forms of Abuse)”**, the Office of the Schools Division Superintendent (SDS) is hereby directed to create/organize and establish a Child Protection Committee (CPC) in all public and private elementary and secondary schools in the region. The CPC of the schools shall consist of the following, to wit:

1. School Head/Administrator- *Chairperson*
2. Guidance Counselor/Teacher- *Vice Chairperson*
3. Representative of the Teachers as designated by the Faculty Club
4. Representative of the Parents as designated by the Parents-Teachers Association
5. Representative of pupils, students and learners as designated by the Supreme Student Council
6. Representative from the Community as designated by the Punong Barangay, preferably a member of the Barangay Council for the Protection of Children (BCPC).

2. The Division Office is likewise encouraged to create its own CPC purposely to comply with the provisions of section 6 paragraphs a-k of the aforestated DepED Order.

3. The Division Child Protection Committee (CPC) shall consist of the following:

1. Schools Division Superintendent- *Chairperson*
2. Assistant Schools Division Superintendent- *Vice Chairperson*
(For the Division with more than one Assistant Schools Division Superintendent, the other Assistant Schools Division Superintendents shall become automatic committee members)
3. Administrative Officer (AO IV) - Member
4. One (1) Education Supervisor (ES) - Member
5. One (1) School Principal (Secondary) - Member
6. One(1) School Principal (Elementary) – Member

4. The Division Office is hereby directed to submit a report of compliance along with the list of the composition of the respective CPC of all schools, (both elementary and secondary, public and private) within thirty (30) days from receipt of this memorandum.

5. Strict compliance is hereby enjoined.
