**REITERATION OF THE NO COLLECTION POLICY
AND OTHER REMINDERS**

To : Schools Division Superintendents
Public Elementary and Secondary School Heads
All Others Concerned

1. The Department of Education Regional Office No. 02 strongly supports the urgent need to minimize, if not eliminate, financial constraints among parents/guardians in the pursuit of their children of quality basic education.
2. In view of the foregoing, the Department has issued DepEd Order 19, s 2008 "Implementation of the No Collection Policy in All Public Elementary and Secondary Schools, DepEd Order 41, s 2012 "Revised Guidelines on the Opening of Classes" and DepEd Order No. 66, s 2012 "Amendments in DO 41, s 2012, and other related Orders and Memoranda for the strict implementation of the "No Collection Policy."
3. Despite the clear provisions contained in the above-stated Orders and constant reminders being made all year round to ensure the proper implementation of the said Orders, this Office has continued to receive complaints and feedback on certain violations by teachers, school personnel or school heads.
4. This reminder, therefore, comes with it a strong warning that any violation of the said Orders shall be dealt with administratively, pursuant to DepEd Order No. 49, s 2006, otherwise known as the "Revised Rules of Procedure of the Department of Education in Administrative Cases."
5. Furthermore, inasmuch as the Schools Division/City Superintendents (SDSs) and the school heads are responsible in the strict implementation of the abovementioned Orders, they shall
