RETIREMENT TRANSITION (HEART) SEMINAR**

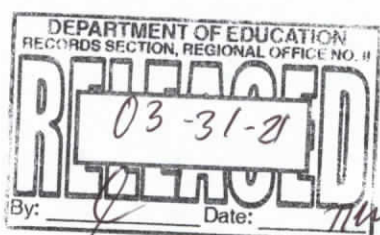
In line with the **RM 046, s. 2021** dated **March 8, 2021** re Conduct of Healthy

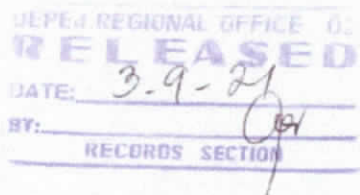
