ONLINE SURVEY ON CHILDREN'S PARTICIPATION IN CLIMATE


ACTION

- 1. The Office of the Undersecretary for Administration (OUA) through the Disaster Risk Reduction and Management Service (DRRMS) and Bureau of Learner Support Services Youth Formation Division (BLSS-YFD), in partnership with Save the Children Philippines (SCP), will conduct a regional study on **Children's Participation in Climate Action** to enhance programs and advocacy on climate action with children in Asia and help in the policy formulation and program development on climate action of the Department of Education (DepEd), SCP, and other partners.
- In this regard, an online survey will be conducted from July 26 to August 6, 2021 with identified DepEd learners aged 10-17 as respondents.
- 3. Select learners may or may not be engaged in climate actions who come from diverse selected schools and can self-administer the online survey. The answer should come solely from the respondent, unaffected or uninfluenced by somebody else present in the area (e.g., father, mother, sister, teacher, etc.) to ensure the reliability of the data.
- The Division YFD Coordinator will be the assigned Survey Coordinator while the Division DRRM Coordinator will act as support.
- 5. A load allowance to defray expenses shall be downloaded in the amount of Php300.00 for the Survey Coordinator and Php50.00 for the Learner Survey Respondent. The Survey Coordinator will distribute the load allowance to the identified learner respondents.
- 6. The following is the distribution of respondents per division and the Coordinator Code Mapping to be used in monitoring the conduct of the survey.


