POSTPONEMENT OF THE PERSONAL FINANCIAL MANAGEMENT TRAINING

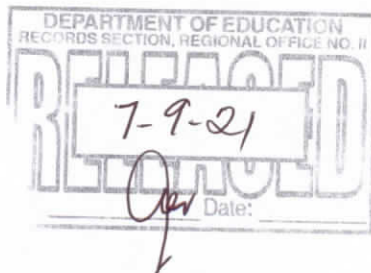

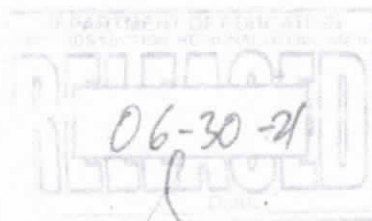
