**Additional Guidelines in the Conduct of the Regional Online Journalympics  
on Photojournalism Contest, School Paper Contest and Further Reminders**

This Office hereby informs the public on the additional guidelines in the conduct of  
the Regional Online Journalympics specifically on photojournalism contest, school  
paper contest and radio broadcasting and scriptwriting contest.

1. Photojournalism Contest

- a. There shall be four (4) entries per division which compose of the following:
  - 1 elementary campus journalist category
  - 1 secondary campus journalist category
  - 1 elementary school paper adviser category
  - 1 secondary school paper adviser category
- b. There shall only be one (1) photo entry per category. The entry to be submitted should be in a JPEG or PNG format with a corresponding “photo caption” with a maximum uploading capacity of 100 mb only.
- c. The photo entry should be taken by the contestant inside their own house/building/compound/residence using any available photo devices such as smartphones, tablets or digital/DSLR cameras.
- d. The photo should not contain any of the following:
  - watermarks or any identifying mark.
  - violate a person’s rights, including, but not limited to copyrights and privacy.
  - previously submitted or won in any photography contest.
  - contain images of elected government officials.
  - edited and manipulated
  - identifiable names or faces of minors.
- e. The caption must indicate the place where the image was taken and must have an accurate description of what the photo is about observing the elements of balanced news and photojournalism.
- f. Deadline of Submission: July 18, 2021. The submission will automatically close and reject any entries that will be submitted after the deadline. All entries shall be submitted through the link <https://bit.ly/PHOTOJOURNALYMPICS>
- g. Voting online shall be on the period of ten (10) days from July 19-27, 2021 at noon. Love votes shall be counted in favor of the contestants which shall compose the 50% of the overall result. Photo entries shall be uploaded to the official journalympics page created by the host division.

2. School Paper Contest

- a. Reiteration on the number of section pages and paper sizes of the newspaper shall still follow the 2020 NSPC Guidelines.
- b. Schools have the option to use full-blown colored pages both inside and outside or the grayscale/gray monochrome/ black and white in their inside pages. There shall be no bearing on the judges' score in the use of the color options.
- c. Focal persons shall submit certification of no-plagiarized articles, a summary of entries and a drive file with categorized entries per section for easier consolidation to [clmd2campusjourn@deped.gov.ph](mailto:clmd2campusjourn@deped.gov.ph) not later than July 16, 2021.

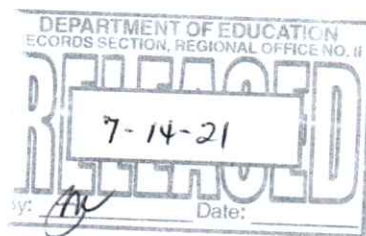
3. Further, The radio broadcasting and scriptwriting contest shall be live at both elementary and secondary levels.

4. All contestants shall submit their parents' informed consent. A signed pdf copy shall likewise be submitted along with the list of official entries and certification of no face-to-face conduct of conferences.
