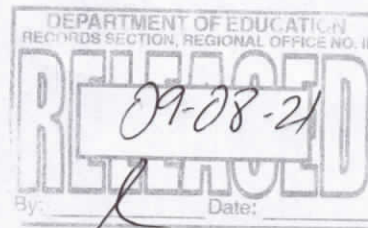
TI PANAGBALIW TI DALAN KO (ANG PAGBABAGO NG DAAN KO) POLICY HACKATHON

Calling all policy hackers! Join the Ti Pinagbaliw Ti Dalan Ko Policy Hackathon and bring out new ideas to the transport woes of your community.

Present tangible solutions and address policy gaps in Region 2's local transport system particularly those that impact the environment and your freedom of movement.

Participate as an individual or a group, develop innovative policy solutions from your own problem statement and enhance your policy hacks through a series of coaching session! You will also have the opportunity to pitch your ideas to legislators, local chief executives and lobby groups who might potentially adapt them to become bills or local ordinances!

Baguhin ang Daan Mo! Submit your policy hacks now!

Mechanics

- Individuals and/or groups are allowed to join. For groups, there should be a maximum of three members.
- The participants must clearly identify a problem statement related to transport and mobility issues in Region 2. Suggested themes of problem statements are: 1) mixed-modal access, 2) clean and non-motorized mobility, and 3) integrated ICT. These are based on the Smart Mobility component of [Cohen's Smart City Wheel](#).
- Ten policy hacks will be shortlisted. The participants will be invited to give a pitch.
- Five will be selected, and will be part of a coaching program to enhance their policy hacks, after which, they will receive P20,000.
- The coaching program shall cover the following topics. Representatives from the local government and field experts will be invited as coaches:
 1. Advocacy – mobility rights and the future of smart cities
 2. Policy paper writing – structure of a policy paper
 3. Pitching – presentation techniques
 4. Communication – strategies on getting messages across
- Apart from an honorarium of P20,000 after the submission of the final policy hacks, the outputs will be featured on the FNF website, and will be published in a booklet.
- One from the five hacks will be selected to receive additional funding of P10,000 for further policy development.
