1. 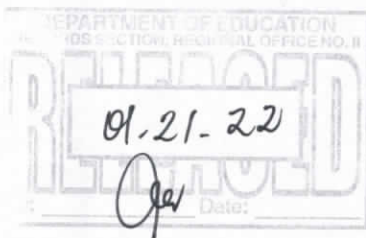
