 FOR THE DIVISION ALS IMPLEMENTERS FOR CY 2022**

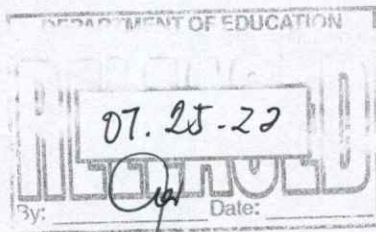


