IMPLEMENTATION RULES AND REGULATIONS (IRR)**

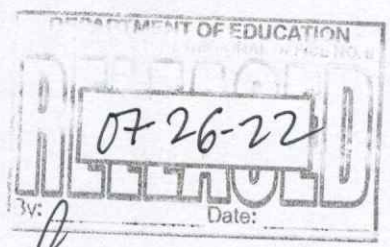
Per reference to Regional Memorandum CLM-2022-018 dated July 22, 2022,
